ANNUAL MEETING

NORMAL TOWNSHIP

The electors of each township annually shall assemble and hold a township meeting in the month of March at the place in the township or in an adjacent township designated by the board of township supervisors. Notice of the time and place of holding the meeting must be given by the township clerk at least ten days before the meeting by publication in a legal newspaper published in the township or, if there is no such newspaper, then in the county's official newspaper.

The qualified electors present on the day of the annual or special meeting must be called to order by the township clerk, or, if the township clerk is not present, the qualified electors may elect by acclamation one of their number to act as chairman for the purpose of calling the meeting to order and to act as clerk after the selection of a moderator.....

.....The qualified electors shall elect by acclamation three of their number as judges, and such judges must be sworn and shall act as the judges of the qualifications of the qualified electors of the township.....

.....The qualified electors shall proceed to choose one of their number to preside as moderator of the meeting.....

At the opening of each meeting, the moderator shall state the business to be transacted and the order in which it must be entertained.....
