# **FUTURE FUNDING DEPENDS ON SURVEY!**

In October the Upper Great Plains Transportation Institute at NDSU mailed out a road needs survey, one to a supervisor in each township. This got a very poor response so now UGPTI has done a second mailing, this time to the clerks of the townships that did not respond to the first.

It is very important that good data can be compiled from this survey as it will be used in making a new funding formula for the "Prairie Dog" funding. The first payment is fixed at nearly \$10,000 that non-oil townships will receive early in 21, but after that the law will require some justification for the payments, some kind of a cost per mile times the number of miles actually maintained.

It is also very important for the townships in the oil producing counties to complete the survey, we know your road cost are very high, get them in so they can be included in the formula for your area. So we can prove to the legislators that oil producing townships really need that money.

If your township did file the survey you do not have to do it again, we are just trying one last time to get as many as possible to respond.

As you see elsewhere in this issue, a new NDTOA President was elected at the 2019 annual meeting last December. For those that were unable to attend, I would like to share the message I gave at the close of the business meeting.

I would like to thank the members of NDTOA that supported me (put up with me?) during my four plus years as Vice President, and then six years as President. Also, many thanks to all the board members I worked with over the years. It was my pleasure to work with so many good member township officers and board members which made my job easy.

I was proud to serve with the management teams that put together a run of ten consecutive years of operating in the black along with many other successes, legislatively and otherwise, that have kept NDTOA strong and an organization well respected by outsiders all across the state. It took much effort by many to accomplish all of this. Of course, Larry Syverson's frugality in running our legislative session presence and his expertise in dealing with lawmakers is a huge factor in our successes.

An action that I initiated when I became President contributed somewhat to the financial condition but was also somewhat disappointing. I called it my pet project, whereby I began a campaign to get counties with unorganized townships to pay membership dues to NDTOA for their unorganized townships. Let's keep working on that as everything gets more expensive each year and any benefits procured by NDTOA efforts are distributed to counties for their unorganized townships in the same manner and ratio as it is to organized townships.

With that in mind, I plan on hanging around for a while and helping if and where I can, including continuing to answer your questions or passing them on to a more knowledgeable source of information.

# The Country Lawyer by Thomas R. Moe, Attorney-at-Law

### Greetings!

They say Winter is the mysterious season—I just think it's cold and dreary. But, baseball's Spring Training is only about a month away, so there is warmth at the end of the tunnel!

Due to some unexpected medical issues plus some hospital procedures, I had to miss our December state convention—the first I've missed in over 30 years. I really wanted to be there to meet and greet every one and field all your questions.

I understand it was a productive session, even though the weather wasn't very cooperative. I must take this opportunity, however, to recognize our outgoing state President, Roger Olafson. I have appreciated his wisdom and good counsel, and he has truly been an outstanding ambassador for NDTOA.

Luckily by virtue of being the immediate past president, he will still be a member of the Board of Directors, and I'm sure we will still rely on him for the definitive answers about Roberts Rules—Roger is hands down our rules guru!

Secondly, congratulations to Lee Brandvold for his election as our new State President. Lee brings a wealth of township experience to the table, and I have admired his forthright, common sense approach to problem solving. And, because so many of us are shall we say "showing our age", Lee adds some needed youthful exuberance and efficiency to NDTOA! I know we all look forward to working with Lee during his tenure. Even though I was absent from the State convention, I had to chuckle, however, as I received about a half dozen phone calls from township officers during the days when the convention was on—although I couldn't chastise them too much for not being in Bismarck, because I wasn't there, either!

Interestingly, the same thing happens during our workshop tours when I sometimes field calls from officers who live right down the road from where the workshop session is being held—that can be quite frustrating!

Speaking of workshops, our biennial tour starts in February, and the schedule is printed elsewhere in this issue. Please consider attending one of the sessions, whether it is the one closest to your home, or at any one of those locations listed.

We always have informative, educational, and timely topics, and most of your questions can be answered on the spot. Attendance, is of course, official township business, so any expenses incurred should be reimbursed by your township.

When one thinks about it, most township residents, plus your absentee landowners, probably would expect their township officers to attend training sessions on a regular basis, and no doubt would be surprised if their elected officers fail to attend!

I know the weather this Fall provided lots of headaches for those trying to finish harvest and other end of season chores, so a lot of the regular end-of-year township duties



got delayed or uncompleted as well—including sign inventories and surveys, road gravelling, and road ditch cleanup. And, I imagine many of our roads never did get a chance to dry up, so we will be dealing with frozen mud and ruts for quite awhile. Hopefully, townships will get a chance in Spring to tackle those problem areas as soon as possible.

I hope to see many of you at the workshops. Here's a few questions I have received in the office lately. TRM

**Question:** Our neighboring township has talked to us about going together and purchasing a truck snowplow. First, is that legal for us to share, and second, the dealer says he would like to see us have a 'joint powers' agreement for his file—what is that?

**Answer:** Yes, townships can go together and purchase equipment such as you describe. I know of several townships that have jointly bought or leased snowplows, road graders, mowing equipment, or park equipment, etc.

A joint powers agreement contains the contractual language between the sharing townships—e.g. how the payments will be made and by which township (which is probably what the dealer is most interested about).

Additional items should include: how insurance, maintenance, fuel, oil, and repairs will be handled; will the operator be an employee, or a contractor; which roads in which township will have priority; who will decide when to call the operator to begin work; etc.

Make sure such a shared agreement is approved by the annual meetings in all townships involved, and approval for funding is also approved by all of the respective township meetings.

P.S. To reduce the amount of complaints that one township appears to get "better work" than the other(s), in the interest of uniformity, I would also require the operator to attend one of the many road training sessions put on by the folks at LTAP. (see their article printed elsewhere in this issue.)

**Question:** We have a landowner that threatens to sue us over any complaint he may have. Lately he claims he can keep his fence inside the right-of-way, and we have no authority to remove it, and if we do, we will see him in Court. Any ideas?

Answer: I've learned a couple things about those that threaten lawsuits—rarely do they follow through (because it will cause them to spend some money!); and, deep down they know that they are wrong and the township is correct. They just figure that if they "bully" you enough times, that you will give in.

Unfortunately, I know some of my fellow lawyers that fall into that category as well. In the situation you mention, the law is quite clear that there can be no obstacles in the ROW — fences included. (Townships can give temporary permission, but obviously your township has not done this). Make an Order in writing to remove the fence within a reasonable amount of time, and if there is noncompliance, have it taken down and at the landowner's expense. If the "bully" persists and sues you, no judge would rule against you because both the facts and the law are on your side.

**Question:** One of our supervisors is designated as the road overseer, as the NDTOA handbook outlines. When the road overseer meets with just one of the other supervisors: is that a quorum for an official meeting?

**Answer:** I've had to change my answer on this one. In a recent Attorney General's opinion, the rule now is that if a "committee" of government officials—even though not a quorum--meets separate from the main body then that is nevertheless a meeting and requires notice and record keeping.

Thus, a road overseer (who is not acting in her capacity as supervisor while being the overseer) meets with another supervisor—that is a "committee" as outlined above. We'll discuss this item plus open meetings/records more in depth at the workshops.

**Question:** Can an absentee landowner participate in our annual meeting? I imagine he wants to complain about the conditions of the roads adjacent to his land.

**Answer:** Any member of the public can attend a township meeting. An absentee landowner, while not a resident, surely can attend, and if allowed to by the chair, could and should make requests/complaints/

wishes known. The absentee cannot vote, however, as only residents are allowed that right.

**Question:** One of our supervisors passed away late last Fall. Rather than appoint someone, the office remained vacant, but we found a resident who is willing to serve and we will elect her at the upcoming March annual meeting. Does she get a 3 year term?

**Answer:** It depends on how much time was left on the deceased officer's term. She should be elected for the remainder of the deceased's term—that way the normal rotation of having only one supervisor elected each year for a 3 year term doesn't get messed up.

This year will be a little different however: (Assume the deceased person had two more years to go on his term). Thus, for this meeting only, you will elect two supervisors in March—one for 2 years, and the other supervisor whose term would normally be up at this annual meeting for 3 years. The normal rotation will then resume in the following years.


My wife, Martha, and I have two grown children, Haley and Griffin, and we actively farm near Casselton.

# **TOWNSHIP OFFICERS OF ROLAND TOWNSHIP GET GRASSROOTS LEADERSHIP AWARD**

For the first time the Grassroots Leadership Award has been given to two officers because of their team efforts to secure funding for a paving project at Lake Metigoshe, in Bottineau County.

About 11 miles of road around Lake Metigoshe were originally paved in 1998 and now needed extensive upkeep and repaving at a cost of \$2.6 million. Township Officers, Mike Hall and Vern Jacobson worked to convince Bottineau County to pledge \$500,000 to the project.

At their request, Representative Dick Anderson introduced HB 1322 in the 2017 legislative session which helped clear the way for the township to bond for the project. Between the county grant and the bonding ability they were able to put together a proposal that could get the needed approval of 60% of affected landowners.




### CASH WINNERS AT 53<sup>RD</sup> CONVENTION!
